
TIE DOWN ROPING SCORECARD GOLD BUCKLE FUTURITIES



CREDITS

- 1. SCORING
 - a. QUIET IN THE BOX (WALKING INTO THE BOX ON A LOOSE REIN)
 - b. SCORING IN THE BRIDLE (STAND IN BOX, LOOKING STRAIGHT, MINIMAL EXTRA MOVEMENTS)
- 2. RUNNING/RATING
 - a. HORSE LEAVES THE BOX FLAT AND IN A STRAIGHT LINE WITH BODY
 AND HEAD
 - b. HORSE DOES NOT RUN TOO CLOSE OR DOES NOT HANG WHEN CHASING THE CALF
 - c. TRACKS THE CALF WILLINGLY WITH MINIMAL ASSISTANCE
- 3. STOPPING
 - a. HORSE RATES THE CALF AND STOPS STRAIGHT
 - b. HORSE HAS GOOD TIMING AND CORRECTNESS WHEN STOPPING (NOT HITTING ON FRONT END EXCESSIVELY)
- 4. ROPE WORK
 - a. HORSE PULLS WHILE CALF IS BRING FLANKED AND STOPS PULLING WHILE ROPER IS TYING CALF.
 - b. HORSE HOLDS THE CALF WITHOUT WALKING UP OR DRAGGING AND IS ALERT AND FOCUSED

SCORING

EACH MANEUVER WILL BE SCORED FROM A 3 (EXCELLENT) TO A -3 (EXTREMELY POOR) IN ONE-POINT INCREMENTS.

TIME LIMIT IS 90 SECONDS

A SCORE CAN BE HELD BY ANY ONE (1) JUDGE TO BE REVIEWED AT THE END OF THE ROUND.

PENALTIES

3 POINTS:

- 2 HANDS IN THE BOX
- RUNNING INTO OR STEPPING ON CALF
- NERVOUS IN THE BOX
- TURNING HEAD SEVERELY IN BOX
- MOVING FEET IN BOX
- SQUATTING IN THE BOX
- HEAD SHAKING IN THE RUN
- OUT OF CONTROL DURING THE RUN

5 POINTS:

- MOVING HIND END OUT OF CORNER (THIS DOES NOT INCLUDE RIDING UP TO RESET)
- SQUATTING IN THE BOX
- COMING OFF OF THE FRONT END IN THE BOX
- BROKEN BARRIER (5 PTS. PER JUDGE)

10 POINTS:

- BREAKING THE BARRIER (TIME SCORE)
- REFUSING TO ENTER THE BOX (LOCKING UP, TURNING AROUND BEFORE ENTERING THE BOX. ETC.)
- BLATANT DISOBEDIENCE AT ANY TIME
 DURING THE RUN (DEFINED AS KICKING,
 BITING, BUCKING, REARING, OR STRIKING)

0 SCORE:

- FAILURE TO CATCH LEGAL (TIE DOWN IS CATCH AS CATCH CAN)
- FALL OF HORSE OR RIDER
- EXCESSIVE SCHOOLING DURING ANY POINT OF RUN
- FAILURE TO WORK IN THE PROPER WORKING ORDER
- FAILURE TO GET HORSE INTO CORNER (3 ATTEMPTS)
- FAILURE TO GET HORSE INTO BOX (3 TIMES)
- COMPETITOR STRIKES HORSE WITH ROPE IN THE BOX
- RIDER TOUCHES THE ROPE AFTER THE CALF
 HAS BEEN TIED


<u>REVIEW:</u> IF THERE IS A 5-POINT OR GREATER DIFFERENCE BETWEEN THE JUDGES' SCORES, A REVIEW WILL BE AUTOMATICALLY TRIGGERED TO ENSURE SCORING ACCURACY AND CONSISTENCY.

DURING THE REVIEW, IN A MULTIPLE JUDGED SITUATION, EACH JUDGE WILL HAVE AN OPPORTUNITY TO RE-ASSESS THE PENATLY IN QUESTION. UNTIL THE REVIEW IS COMPLETE AND A FINAL DECISION IS MADE, THE PENALTY SHALL REMAIN ON THE SCORE SHEET AS ORIGINALLY MARKED.

IN A MULTIPLE JUDGE SYSTEM, WHEN THERE IS A MAJOR PENALTY MARKED BY AT LEAST ONE JUDGE, AND AT LEAST ONE OF THE OTHER JUDGES DID NOT MARK IT, A REVIEW OF THE PENALTY IS MANDATORY.
